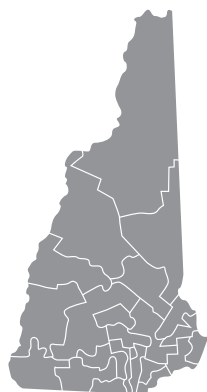

NEW CRIMINAL CASES

New Hampshire initiated **0** new criminal human trafficking cases in 2018, ranking it last in the nation with 19 other states and territories.



ACTIVE CRIMINAL CASES

New Hampshire had **2** criminal human trafficking cases active in 2018, ranking it 45th in the nation for number of active cases.

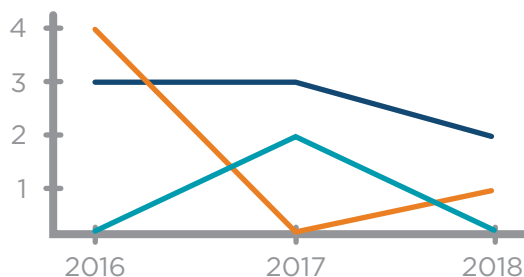


CONVICTIONS

New Hampshire convicted **1** defendant in a human trafficking case in 2018, ranking it 36th in the nation for number of defendants convicted.

RESTITUTION



New Hampshire ordered **0** defendants to pay restitution in 2018, ranking it last in the nation with 25 other states and territories.



The **1** conviction in 2018 was in a case with no identified victims.* Accordingly, **0** defendants were ordered to pay restitution.

*This conviction has been excluded for purposes of restitution calculations. It is uncommon for federal courts to order restitution in a case where the government does not identify a trafficking victim (e.g., sting operation cases).

NEW CRIMINAL LABOR TRAFFICKING CASES

New Hampshire was **1** of **49** states and territories that failed to initiate a criminal labor trafficking prosecution in 2018.

Nationally, the most common type of exploited labor in labor trafficking cases active in 2018 was domestic work. Over half of the active labor trafficking cases involved a defendant using threats of deportation to coerce labor or services.

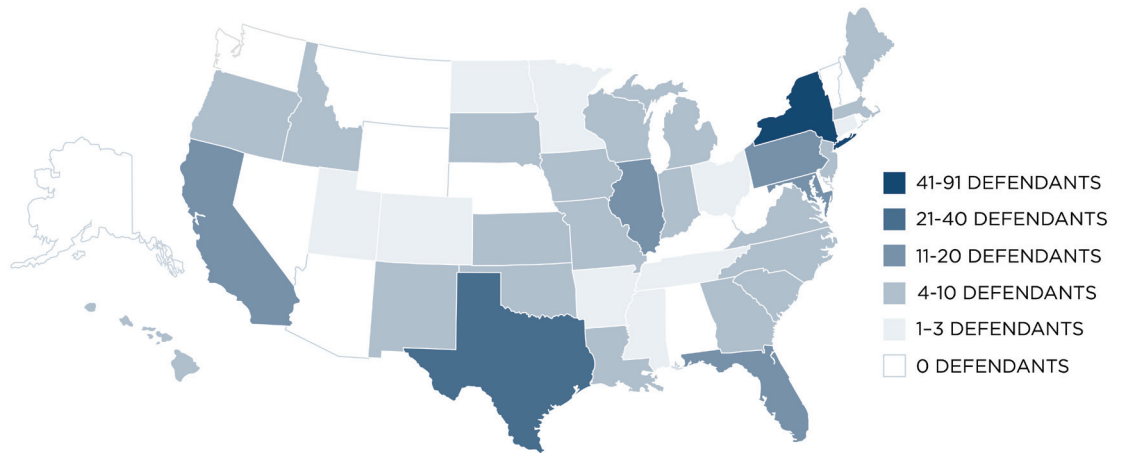

NEW CRIMINAL HUMAN TRAFFICKING DEFENDANTS



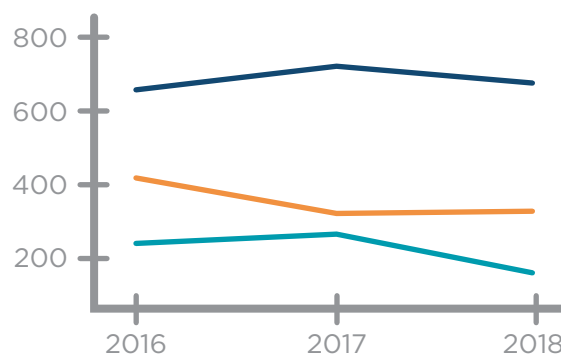
CIVIL CASES



Plaintiffs filed only **31** new civil human trafficking suits in federal courts nationwide. Of the new civil cases, **87.1%** were labor trafficking cases and **12.9%** were sex trafficking cases.
