







NEW CRIMINAL CASES BY DISTRICT

NEW CRIMINAL CASES

Pennsylvania initiated 11 new criminal human trafficking cases in 2018, ranking it 3rd in the nation for number of new cases.



ACTIVE CRIMINAL CASES


Pennsylvania had 42 criminal human trafficking cases active in 2018, ranking it 5th in the nation for number of active cases.



CONVICTIONS

Pennsylvania convicted 10 defendants in human trafficking cases in 2018, ranking it 10th in the nation for number of defendants convicted.

RESTITUTION



Pennsylvania ordered 3 defendants to pay restitution in 2018, ranking it 12th in the nation for restitution orders.

Pennsylvania was 1 out of 49 states and territories that failed to initiate a criminal labor trafficking prosecution in 2019

NEW CRIMINAL HUMAN TRAFFICKING DEFENDANTS



CIVIL CASES

Plaintiffs filed only 31 new civil human trafficking suits in federal courts nationwide. Of the new civil cases, 87.1% were labor trafficking cases and 12.9% were sex trafficking cases.
